The following case relates to the impact of travel advisories on Caribbean countries. Read the case carefully and answer ALL the questions that follow.

CASE

Caribbean countries find it especially challenging to portray a positive image to visitors. This was reported by a research institute that conducted a study on the negative impact of travel advisories on the image and economies of these countries. The research institute recommended that these countries dedicate more resources to attaining and maintaining a positive image in the international community. The institute further recommended that the countries of the region engage not only locals, but also the people of the diaspora in their efforts to change the perceptions of travellers to the region.

The CARICOM Secretariat commissioned the study after the United States issued another in its series of travel advisories, warning its citizens of the perceived dangers of travelling to countries in the Caribbean region. This latest advisory warned citizens to be extra cautious as they were in danger of being kidnapped and held for ransom, raped or murdered. Governments in the region have consistently argued that such advisories caused considerable damage to the image and tourism potential of the region.

The research institute, a Chinese government agency, was contracted to conduct the study in which they were to identify the extent to which travel advisories influenced the decision of tourists on where to spend their holiday. They were further mandated to recommend ways in which the countries of the region could overcome the negative publicity and resulting political, social and economic fallout caused by the issuing of travel advisories.

The research institute conducted a survey as a means of gathering the necessary information. Citizens from the Dominican Republic, Grenada, Antigua, Saint Lucia, Suriname and Belize were interviewed. Five hundred telephone interviews were conducted in all of the selected countries over the three-month period of data collection. The data were analysed and the report handed over to the CARICOM Secretary General. The secretary general argued for the report's recommendations to be implemented forthwith across the entire region and, at the same time, urged countries to be more mindful of the effects of such advisories on the economic stability of the countries of the region. Meanwhile, the Chinese government, which funded the study, floated the idea of providing financial support to enable countries to overcome negative fallout.
